### Travel Insurance (Required)

#### Guest Responsibility

All guests are required to obtain and maintain **comprehensive travel insurance** for the full duration of their travel, including travel days to and from the retreat.

**Travel insurance is a condition of participation** in Soulie Retreat.

#### Required Coverage Must Include:

- Trip cancellation
- Trip interruption
- International medical coverage
- Emergency medical evacuation and repatriation
- Coverage for airline delays, cancellations, and missed connections

Guests are responsible for selecting and purchasing their own travel insurance policy.

For convenience, many guests choose providers such as **World Nomads, Allianz Travel Insurance, or Travel Guard (AIG)**. Guests may select **any provider of their choice**, provided the policy meets the coverage requirements listed above.

### Airport Transfer Shuttles to / from Liberia Airport (LIR)

- Guests are responsible for booking their own flights to and from the retreat destination.
- \*Group airport transfer shuttles during the designated arrival and departure times are included as part of your stay. Transportation outside of these scheduled shuttle times may be arranged at an additional cost.
- Guests should plan to **arrive** on Thursday, April 23, 2026 by 5:00pm and **depart** on Monday, April 27<sup>th</sup>, 2026 after 12:00pm.

## Passport & Visa Requirements

### Passport Requirements

- A **valid passport is required** for travel to Costa Rica.
- Passport validity requirements are determined by the destination country and airline.

### Visa Requirements

- Visa requirements vary based on citizenship.
- Guests are solely responsible for determining whether a visa is required for entry.
